



### STANDARDISED PRICE LIST

All funeral directors are legally required to publish this Price List for a standardised set of products and services. This is to help you think through your options and make choices, and to let you compare prices between different funeral directors (because prices can vary).

# ATTENDED FUNERAL (funeral director's charges only)

| This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.   | £2025     |

| Collecting and transporting the deceased person from the place of death (normally within 15 miles of the funeral director's premises) into the funeral director's care.   | £200      |

| At a date and time you agree with the funeral director, taking the deceased person direct to the agreed cemetary or crematorium (normally within 20 miles of the funeral director's premises) in a hearse or other appropriate vehicle. | £400      |

#### **UNATTENDED FUNERAL**

This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.

<sup>\*2</sup> In England, Wales and Northern Ireland, you will usually need to pay doctors' fees as well. This is the charge for two doctors to sign the Medical Certificates for Cremation.
